This five (5) hour Environment Rating Scale (ERS) training is a MANDATORY requirement for all new CARES/AB 212 Stipend Program participants and for returning participants who have never completed an ERS training with a Riverside County Child Care Consortium (RCCCC) approved trainer. An ERS Score Sheet and an ERS Needs Improvement Plan must be correctly completed and submitted within 30 calendar days of the completion of this training to qualify for a 2009-2010 CARES/AB 212 stipend.

- ❖ Return completed registration form with the \$25 fee to the Riverside County Child Care Consortium (RCCCC) office.

- ❖ Cash, Checks, Money Orders and Cashier's Checks are accepted for payment. RCCCC is not able to process credit or debit cards.
- ❖ Please make checks payable to "RCCCC."
- ❖ One (1) registration form per person, please make copies if more are needed.
- ❖ Space is limited, if the requested workshop is full, your registration will be returned – please list a first and a second training choice on the Registration Form.
- ❖ Workshop registration must be received and approved by the RCCCC office prior to the workshop date. Walk-in registration the day of the workshop is not permitted.
- ❖ There is a \$5.00 Rescheduling Fee for ANY and ALL schedule changes. –NO EXCEPTIONS  
*Changes must be made PRIOR to workshop date. At least one (1) week advance notice is required for any workshop changes.*
- ❖ Workshop "No-Shows" will need to re-register and pay an additional \$25 Registration Fee for a future workshop.
- ❖ Workshops start promptly at scheduled times. Participants arriving late will NOT be admitted.
- ❖ Please note: Children of any age are not allowed at trainings, please make arrangements in advance.
- ❖ Due to space limitations, only registered participants will be allowed in the facility during trainings.
