- No phone registration is available. Payment must be mailed or walked into the RCCCC office one week prior to the start of your workshop (make checks out to “RCCCC”).
- One (1) registration form per person, please make copies if more are needed.
- Space is limited, if the requested workshop is full, your registration fee will be returned.
- Only registered participants may attend, child care will not be provided.
- Confirmation letter is required for admittance. If a confirmation was not received, please contact the office.
